### **Jenner Property**

#### **Jenner Shallow Gas Gathering System Wells**

- 10-34-019-09W4 Sweet Gas Facility
  - o Cor4 Operated, Cor4 87% Working Interest
  - o Compression and dehydration facility with ~8 MMcf/d design capacity
  - o Sales gas is dually connected to TCPL/Nova (Jenner West at 13-14-020-09W4) and to Empress (via a third party pipeline connection at 04-14-020-09W4 that delivers to the Campus-Suffield Gas Transportation System), allowing Cor4 to realize AECO and/or Empress gas pricing.
- Field shallow gas booster compressors:
  - o 16-07-020-08W4 – Cor4 Operated, Cor4 100% WI

#### **Princess Shallow Gas Gathering System Wells**

- 8-16-020-10W4 Gas Facility
  - o Cor4 Operated, Cor4 100% Working Interest
  - o Compression and dehydration facility with ~8 MMcf/d design capacity
  - o Sales gas is connected to TCPL/Nova (Princess-Iddesleigh at 16-16-020-10W4).
- 14-23-019-10W4 Gas Facility (not currently being utilized for Cor4 production)
  - o CNRL Operated, Cor4 39.9% Working Interest
  - o Compression and dehydration facility
  - o Sales gas is connected to TCPL/Nova (Tide Lake North at 03-26-019-10W4).

### **Dinosaur / Patricia Property**

- TAQA North Operated, Cor4 49% Working Interest (Dinosaur Unit No. 1 and Patricia Gas Unit No. 1)
  - o 13-05-021-12W4 gas compression facility with sales gas connected to TCPL/Nova (Patricia at 13-05-021-12W4).
  - o 11-13-021-12W4 gas compression facility with sales gas connected to TCPL/Nova (Wardlow East at 15-24-021-12W4).
